Role specification

The Journal Pathology: Clinical Research was founded in 2015 as the Open Access companion to The Journal of Pathology to publish clinically-orientated articles focused on the mission of The Pathological Society: Understanding Disease, Guiding Therapy. The Pathological Society of Great Britain and Ireland, and Wiley, as joint owners of the Journal, are seeking a Deputy Editor to support the Editor in Chief, Professor C Simon Herrington. Professor Herrington has indicated that he wishes to step down as Editor in Chief at the end of 2024 and it is anticipated that the Deputy Editor will succeed him as Editor in Chief. This appointment therefore represents an excellent opportunity for the successful candidate to gain experience of leading and developing this fully Open Access journal, which publishes papers that further the Society's 'Understanding disease, Guiding Therapy' mission. This post is associated with payment of an honorarium, as agreed between the successful candidate and the Society/Publisher.

The current editorial team comprises:

Editor in Chief – C Simon Herrington

Senior Scientific Editor - Richard Poulsom

Associate Editors – Will Cross, Joanne Edwards, Ricardo Lastra, Andres Matoso and Tilman Rau

The main components of the role are:

- (a) to participate in the development of journal strategy, in conjunction with the editorial team, The Pathological Society and the Publisher
- (b) to co-lead the editorial team
- (c) to co-manage the editorial functions of the Journals
- (d) to solicit the submission of high-quality contributions to the Journals and to invite authors to write review articles, perspectives and commentaries
- (e) to co-lead the process by which submitted contributions are evaluated, in accordance with editorial policy, and select contributions suitable for external peer review
- (f) to co-supervise the independent peer review of contributions
- (g) to contribute to the determination of editorial policy and all procedures and standards for the acceptance of manuscripts
- (h) to meet and confer with the Publisher's personnel at such times as the Publisher and the Society reasonably request (usually online, sometimes in person)
- (i) to use an editorial office system, currently ScholarOne Manuscripts[™], for the receipt of submissions and management of the review process, in liaison with the Editorial Office and other Editors.
- (j) to attend such conferences as are deemed appropriate by, and agreed in advance with, the Society and the Publisher, to assist in the promotion of the Journals. Travel and expenses will be paid from an expense budget agreed between the Society and the Publisher.
