

## **The Jean Shanks Foundation & Pathological Society Clinical Lecturer Grant**

The Jean Shanks Foundation and Pathological Society of Great Britain & Ireland (JSPS) have established a new grant award scheme aimed at histopathology trainees post PhD/MD who wish to continue research part-time whilst completing clinical training (part-time). The grant provides up to £200,000 over a maximum of 4 years and is intended to cover 50% of salary costs (with 50% of salary provided by the NHS – similar to NIHR Clinical Lectureships) and provides up to £15K consumables per year. The trainee may be a trainee Histopathologist or a dental / oral pathologist based in the United Kingdom or Ireland.

Applications will be judged by a peer review process which will focus on the personal qualities and motivation of the candidate, the relevance and quality of the research training programme, the originality and quality of the proposed research project, the strength of the supervision arrangements, the research infrastructure, as well as the benefits to the individual, to the Pathological Society and to the Jean Shanks Foundation. This peer review process will involve members of the Pathological Society Research Subcommittee, nominees of the Jean Shanks Foundation and invited reviews from selected external reviewers (coordinated by the Chair of the Pathological Society Research Subcommittee).

### **The terms and conditions of the Clinical Lecturer Award are as follows:**

1. Applicants must be trainee members of the Society, based in Great Britain or Ireland, in a recognised Specialist Trainee in Histopathology or Dental / Oral Pathology (post FRCPath part 1 or within 6 months of taking the exam). Applicants should have been a member of the Society for at least 12 months.
2. The application form must be completed no later than **1 April & 1 October**.
3. Projects cannot be supervised by first- or second-degree relatives
4. Grants will normally last for 2-4 years (the length must be specified in the application – allowances are made for maternity and paternity leave) and a one-page report on the progress of the research must be sent to the Deputy Administrator within three months of the completion of each year of the award. **Failure to provide a report will preclude future support in this and other schemes run by the Society.**
5. If possible, the scientific and/or medical data derived from the work supported by the grant should be presented at one of the Society's meetings within 2–3 years of the award. Such data should also be published in primary peer-reviewed journals. Any publications or related presentations at meetings by the recipient emanating in part or whole from the Society's support should be duly acknowledged and copies sent to the Society's Deputy Administrator.
6. The Society will normally withdraw funding if the grant is not acknowledged and accepted within 6 months of the offer.
7. All recipients of JSPS funded schemes are required to attend a national JSPS research scheme progress review meeting and take part in appropriate public relations activities. Online application form and more detailed Guidance Notes for the Clinical Lecturer Award are available online from the Pathological Society website [www.pathsoc.org](http://www.pathsoc.org) Applications are reviewed by the Research Subcommittee together with discussions with nominees from the Jean Shanks Foundation and external reviewers. Shortlisted applicants will be interviewed and advised of a decision as soon as practicable after interview process.
8. To develop research strategy, the Society will routinely review academic career progression, and successful applicants are required to provide this information annually.
